

RULES FOR THE "RESPONSIBLE DRINKING QUIZ" COMPETITON RUNNING FROM 10 TO 23 MAY 2022

Article 1 - Organiser

Article 2 - Duration and conditions of access to the game

2.1 Duration:

- Participation in the competition implies acceptance, without reservation, of these rules.
- The prize is not transferable.
