Christian Porta, President of spiritsEUROPE



David O'Sullivan, Senior Counsellor - Steptoe and Johnson LLP

Christian Porta became President of spiritsEUROPE in November 2017.

On 1 July 2018, Christian was appointed Managing Director, Global Business Development of Pernod Ricard. He was Chairman & Chief Executive Officer of Pernod Ricard EMEA / LATAM between 2013 and 2018.

Christian started his career in Audit Services at Arthur Andersen, where he worked for four years before joining Pernod Ricard in 1988 as an Internal Auditor, following which he became Head of Financial Services at the holding. In 1994 he was appointed Finance and Administration Director at Pernod, before moving to London in 1998 as Managing Director of Campbell Distillers.

In 1999 he was appointed Chairman and CEO of Orlando Wyndham, based in Australia, before moving back to London at the beginning of 2004 as Chairman and CEO of Chivas Brothers Ltd.

David O'Sullivan served as Ambassador of the European Union Delegation to the United States from November 2014 until February 2019.

Prior to his appointment as Ambassador, he was the Chief Operating Officer of the EU's new diplomatic service, the 'European External Action Service'. He had previously held a number senior positions within the European Commission including Director General for Trade (2005-2010); Secretary General of the European Commission (2000-2005); and Chief of Staff to Commission President Romano Prodi (1999-2000). Before joining the Commission, he started his career with the Irish Department of Foreign Affairs and Trade (1977-1979).

He is a graduate of Trinity College, Dublin and the College of Europe (Bruges), and holds Honorary Doctorates from the Dublin Institute of Technology and Trinity College Dublin. He was awarded the EU Transatlantic Business Award by the American Chamber of Commerce in 2014.

In November 2019, he joined the Brussels office of the law firm of Steptoe and Johnson LLP as a Senior Counsellor.



Ignacio Garcia Bercero, Director, DG Trade - European Commission

Ignacio Garcia Bercero is currently a Director in DG Trade (Directorate A) with responsibility for multilateral affairs, strategy and economic analysis.

Since 2012 he has been responsible for overseeing EC activities in the fields of Neighbouring Countries, US and Canada. He coordinated the work of the EU-US High Level Working Group on Growth and Jobs and was Chief Negotiator for the TTIP negotiations.

He has worked at the European Commission since 1987. Between 2005 and 2011 his work focussed on Sustainable Development and Bilateral Trade Relations (South Asia, South East Asia, Korea, EuroMed and the Middle East). During this time he was also the Chief Negotiator for the EU-Korea and EU-India Free Trade Agreements. Before that, he dealt with WTO Dispute Settlement and the Trade Barriers Regulation. In the period leading to the launch of the DDA negotiations, he worked orking on the overall coordination of WTO Policy and was Chief Negotiator on Trade and Competition.

During the Uruguay Round, he followed, inter alia, negotiations on Safeguards, GATT Articles, Functioning of the GATT and, Trade and Environment. He has also been posted to the EU Delegation to the United Nations in New York.

He has written several papers and publications on Trade Laws, GATT and the WTO System, Safeguard Measures, Trade and Competition, DSU Reform and Dispute Settlement in European FTAs.

Ignacio Bercero has a Law Degree from the Law Faculty of Universidad Complutense, Madrid and a Master of Laws Degree (with Distinction) from University College London. He recently completed a Fellowship at Saint Anthony's College Oxford. His research focused on WTO reform, including both its negotiating and adjudicating functions.

Marie-Pierre Vedrenne is Vice-Chair of the Committee on International Trade and of the ACP-EU delegation. She is also full Member of the Committee on Employment and Social Affairs and substitute in the Committee on Petitions.

Graduate in European and WTO law, she has an in-depth knowledge of the European Union's trade policy. Marie-Pierre led the Maison de l'Europe in Rennes before her election to the European Parliament. She continues to work in building bridges between the EU, its institutions and its citizens.

In Brussels and Strasbourg, she works daily to put an end to all forms of unfair competition in the European Union and on the international scene, while defending a rules-based, fair and sustainable globalisation. In the Committee on Employment and Social Affairs, she is committed to defending and strengthening upward social convergence and a socially fair Europe, especially in the recovery context.

Since 1 July 2020, **Claire Bury** is Deputy Director-General at the Directorate-General "Health and Food Safety" (SANTE) of the European Commission.

Between January 2016 and July 2020, she was Deputy Director General in DG CONNECT with responsibility for regulatory aspects of the Digital Single Market.

She was previously Director of Modernisation of the Single Market in Directorate General Internal Market, Industry, Entrepreneurship and SMEs.

Before that, she was Head of Unit for Company Law, Corporate Governance and Financial Crime in Directorate General Internal Market and Services, and Deputy Head of Cabinet to Internal Market Commissioners Charlie McCreevy and Frits Bolkestein.

An English barrister by training, she worked in the Commission's Legal Service and, before coming to Brussels, in the UK Foreign and Commonwealth Office.




Agné Vezbergiené, "Consumer Products and Retail Sector" lead - Deloitte
