FRANCESCA STEVENS - Managing Director EUROPEN

Francesca Stevens will provide an update on the ongoing review of the Packaging and Packaging Waste Directive (PPWD). The presentation will inform participants of the state-of-play of discussions on the review, explain what is at stake and the opportunities this review brings for the packaging sector. The presentation will also explore how a rigorous implementation of the Single Market principles are key to ensure the success of the European Green Deal and upcoming revised PPWD.

Francesca Stevens is the Managing Director of EUROPEN, the European Organisation for Packaging and the Environment, comprised of companies representing the packaging supply chain and national packaging associations. As experienced public affairs professional, prior to joining EUROPEN, Francesca led Government Affairs and Business Development in the European region for global aluminium leaders Arconic and Alcoa, and held public affairs roles at Hyundai Motor Company, the Confederation of Italian Industry and Alcan. Francesca holds a degree in Political Science and International Relations from the University of Turin in Italy and a Master of Art's Degree in European Studies from the College of Europe in Warsaw, Poland.



VANESSA CHESNOT - Senior Product Policy Manager, FEVE - the European Container Glass Federation

Spirits drinks are one of the container glass industry's leading customers, with most products packed in glass. Glass is a permanent material that is 100% and infinitely recyclable and reusable in local closed loop systems. FEVE will provide an opportunity to learn about concrete initiatives by the container glass industry to offer a climate-neutral and circular packaging solution in line with the EU's Green Deal agenda. Vanessa will also highlight the importance of partnerships across value chains to drive this transition to a climate-neutral EU Circular Economy.

Vanessa is Senior Product Policy Manager at FEVE, the European Container Glass Federation, dealing in particular with Circular Economy topics and coordinating Close the Glass Loop, a multi-stakeholder partnership to establish a material stewardship programme that will result in more bottle-to-bottle recycling. Formerly a Director and Head of Practice at Grayling's Brussels, she counseled clients in the transport, environment, energy and food industries. Vanessa also worked at the Representation of PSA Peugeot Citroën to the EU, handling environment, transport, consumer and competitiveness issues.

PPWD, EGD, CEAP, XYZ - what does it mean to me?



MIKE TURNER - Managing Director, ECMA - the European Carton Makers Association

Mike will discuss the sustainability attributes of fibre packaging and the value folding cartons bring to spirits packaging whilst touching on the legislative tsunami emanating from Brussels coupled with the changing political landscape.

Mike Turner is the Managing Director of the European Carton Makers Association (ECMA) who are the 'voice' of the European carton sector, representing over 500 companies with 50,000 staff. Mr Turner joined ECMA in September 2019 from Graphic Packaging International, where he served as Managing Director of their EMEA Foodservice Packaging business. Prior to that, Mr Turner spent 14 years with International Paper, working in positions of increasing responsibility culminating in the position of Managing Director of their EMEA Consumer Packaging Business and Senior Lead Team member of their Global Foodservice Packaging Business. Prior to that, Mr Turner spent 10 years with M-Real, a Scandinavian paper mill and merchant group. Mr Turner has also served 4 years as President and Chairman of the Brussels based 'Pack2Go' representing manufacturers of packaging for food & beverages 'to go'. Mr Turner serves on the Board of 'First Steps' which is a UK based family & child support Charity.

The revision of the EU Packaging and Packaging
Waste Directive



DAVID BUHE - Policy Officer for Packaging and Packaging Waste Directive - European Commission DG ENV (B.3)

David will provide an update on the process and next steps of the revision of the PPWD which has the clear objective to propose new ambitions on waste prevention. The current thinking of the European Commission on objectives & targets will be explained with a view to waste reduction targets for, a.o., the spirits sector as well as the revision of the Essential Requirements.

David Buhde is Policy Officer for Packaging waste at the European Commission. He is actively involved in the review of the Packaging Waste Directive that will focus on waste prevention and products design. Previously, at the French Ministry of Ecology, he was responsible for the European Plastic Pact signed in 2020 to achieve better lifecycle management of plastics. In 2019, he was in charge of environmental priorities (climate change, biodiversity and ocean protection) for the French presidency of the G7. He also has a background in Maritime Administration and worked for 5 years in the protection of the oceans including fighting against all forms of pollution. He focused his efforts in building a network of stakeholders to tackle plastic pollution on the coast.



KRASSIMIRA KAZASHKA - Technical Director at FEFCO - The European Federation of Corrugated Board Manufacturers

Krassimira will present the sustainability credentials and other benefits of cardboard corrugated packaging. A circular product with a spirit used as secondary or transport packaging to pack and protect around 75% of the goods in Europe. Packaging with many strengths like renewability and recyclability aiming to meet the business needs of the customers and supporting the EU ambitions. The presentation will also elaborate on the challenges and opportunities for transport packaging coming from the review of the Packaging Waste Directive.

Krassimira Kazashka is the Technical Director of FEFCO which represents over 400 companies producing cardboard corrugated packaging. In her role, she is responsible for sustainability and technical issues, EU public affairs and policies. Prior to joining FEFCO in 2014, she worked in industry, national government, and the European Commission. Krassimira holds an MSc in Chemical Engineering, a European MSc in Environmental Protection and an MBA from Vlerick Business School, Belgium.

Mainstreaming reuse for a circular future



EMILY LIN - Global Packaging Sustainability Program Manager - Diageo

Now more than ever, consumers and policy makers alike are expecting producers to reduce waste and take ownership of the end of life of packaging materials. Designing packages to be recyclable and reducing virgin content are steps to improve the environmental impact, but as an industry we will almost certainly need to pursue more drastic measures to be able to meet our packaging emissions targets. Reuse supply chain models are regionally adopted in developing economies but have yet to gain mainstream appeal in most developed markets. The variety of commerce channels, local and varied regulations on alcohol, global supply chains, and consumer behavior all impact the ease of implanting a more widespread reuse model. This presentation will address to unique challenges to the spirits industry and the opportunity to mainstream reuse models for a circular future.

Emily Lin has been with Diageo for 11 years in various technical roles in the US and in Singapore. She is currently leading Diageo's global strategy on how the company can reinvent packaging, covering everything from material choices, formats of packaging as well as supply chain models. Emily has a personal passion for conservation and is always seeking new, innovative ways to reduce her family's carbon footprint.
